## GENERAL INFORMATION CLAUSE FABIOS S.A.

Pursuant to Article 13(1–2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR) (OJ L 119, p. 1), we wish to inform as follows:

- 1. Your personal data shall be administered by FABIOS S.A. with its seat in Białka at the address: Białka 556, 34-220 Maków Podhalański, entered in the Register of Entrepreneurs of the National Court Register held by the District Court for Krakow-Śródmieście, 12th Commercial Department of the National Court Register, as number KRS: 0000277728, VAT number (NIP): 5520100851, REGON: 000568166 (hereinafter referred to as PDA).
- 2. As regards protection of your personal data, you can contact PDA at the e-mail address: odo@fabios.com.pl
- 3. Your personal data (including your image) shall be processed for the purpose of:
  - a) performing the agreement (e.g. sales agreement or cooperation agreement), if concluded (under Article 6(1)(b) of GDPR);
  - b) concluding the agreement (e.g. sales agreement or cooperation agreement), based on your interest in our offer (under Article 6(1)(b) of GDPR);
  - c) offering your our products and services directly (direct marketing), pursuing our legally justified interest (under Article 6(1)(f) of GDPR);
  - d) for the purpose of possible determination, investigation, or defence against claims, in pursuit of our legally justified interest (under Article 6(1)(f) of GDPR);
  - e) for analytical purposes (better choice of services according to our customers' need, general optimisation of our products, optimisation of service processes, building knowledge about our customers, financial analysis of our Company, etc.), in pursuit of our legally justified interest;
  - f) for archival (evidence) purposes in pursuit of our legally justified interest to secure information in the event of legal need to evidence facts (under Article 6(1)(f) of GDPR).
- 4. Your personal data shall be received by entities collaborating with FABIOS S.A.: legal offices, insurance companies, audit offices, transport companies, courier companies, logistic companies, postal operators, certification bodies, tax authorities, veterinary authorities, customs services.
- 5. Your personal data shall not be transmitted to a third country or an international organisation (outside the European Economic Area, hereinafter EEA).
- 6. Your personal data shall be stored until claims under the agreement have expired or until the expiry of the legal duty to store data, in particular referring to the duty to store accounting documents regarding the agreement.
- 7. You have the right to access your data and the right to adjustment, deletion, limitation to processing, right to transfer the data, right to object, right to withdraw your consent for processing at any time, without affecting the conformity of processing completed pursuant to the consent expressed before such withdrawal.
- 8. You have the right to appeal to the President of the Personal Data Protection Office if you decide that the processing of your personal data is in breach of GDPR.
- 9. Provision of your personal data is done on voluntary basis.
- 10. Your data can be processed in an automated way, also including profiling. Profiling shall involve possible proposals regarding products/services best suiting your needs, yet any binding decisions will not be automated.

The above data shall apply to all agreements concluded with the Administrator.
